Re: Special Town Council Meeting - July 13, 2023  
Talmon Infrastructure Improvement (DE) Agreement

To Whom It May Concern:

I noticed on the La Conner Weekly News that Mayor Ramon Hayes has scheduled a Special Town Council Meeting for July 13, 2023 at 10:45 a.m. to approve the Talmon Infrastructure Improvement (DE) Agreement.

Please find below for the record my objections to this specially called meeting:

1. Despite the July 11, 2023 agenda reflecting this issue as "Unfinished Business", I do not see anywhere in the agendas available on the Town of La Conner website that this issue has been previously discussed. Thus, placing it under the "Unfinished Business" categorization improperly informs residents that it is merely an unresolved issue instead of one that may require their attention. See the attached<sup>2,3</sup>.

This is important for several reasons:

- a. The meeting minutes from July 11, 2023 have not yet been posted for review by residents who were unable to attend.
- b. Residents deserve the opportunity to review this document and the minutes to ensure the Town has made appropriate arrangements to

make sure the surrounding homes, businesses, etc. have been properly protected with insurance policies, bonds, etc. and that the Town has not chosen to waive the requirement for these protections in favor of the Developer.

- c. To inform residents that they will be paying for infrastructure improvements for a project the majority of whom vehemently oppose for a minimum of a ten-year period. And the Town and its residents will likely be paying to maintain and for the impact on the current infrastructure, etc. for likely longer than ten years.<sup>4</sup>
- d. To ensure that the cost assessed by the Town to the Developer is reasonable and anticipates any unforeseen costs that may be absorbed by the Town should the Developer fail to comply with current code, etc.

A shortage of time prevents me from providing a more thorough investigation of this issue.

However, these objections should be reason enough to cancel tomorrow's hastily scheduled meeting to give residents a fair opportunity to review how the Town is spending its tax dollars, despite strong objections to the project involved.

Lastly, the fact that the Town has agreed to allow the Atkinsons to name this the "Talmon" project despite Linda Talman's efforts to quash it is in extreme poor taste.
