Original Agreement #C20170135

Town of La Conner, hereinafter called "TOWN," and Skagit County hereinafter called "COUNTY," agree to amend Agreement No. C20170135, as set forth below under "Terms of Amendment."

TERMS OF AMENDMENT: The TOWN and COUNTY agree that the terms of this agreement be amended to extend the term of the contract for a one year period from 11:59 p.m., December 31, 2019, to 11:59 p.m., December 31, 2020, pursuant to the extension permitted under Agreement No. C20170135 at provisions number 9.0 and 14.0.

The TOWN and COUNTY agree for the calendar year 2020, pursuant to Agreement No. C21070135 provision 7.3, to a 3% increase above the amounts set forth for 2019, in Exhibit C to Agreement No. C20170135 constitutes the evaluation of the parties regarding the costs and revenue under Agreement No. C21070135 provision 7.3, with the resulting amount to the costs as follows:

2020: Three hundred and twenty one thousand, four hundred and fifty three dollars (\$321,453) for the calendar year 2020. Payment to be made in the amount of eighty thousand, three hundred and sixty four dollars (\$80,364) paid quarterly on or before March 31, 2020, June 30, 2020, September 30, 2020, and December 31, 2020.

The TOWN and COUNTY agree that Agreement No. C21070135 provision 7.1 is amended to correct the scrivener's error changing references to "Exhibit D" to read "Exhibit C."

All other terms and conditions of the original contract shall remain in effect during the period of the extension provided by this amendment.
